- 본인이 직접발급 (발급진행 시 얼굴스캔 및 여권, 이메일 필요)
- 비용은 1인 A\$20

1) 신청 시 유의사항

- 여권과 유효한 이메일 주소 준비
- 가족 여행의 경우, 한꺼번에 신청 불가하며 다 개별적으로 신청서 제출해야 합니다.
- 신청자 핸드폰이 아니더라도 타인의 핸드폰에서 ETA 앱 설치 후 대신 신청서 제출 가능.


다만 대리 신청의 경우 반드시 신청자 본인이 같이 현장에 있어야 함(신청자의 사진 촬영 제출하는 과정이 있습니다)

2) 신청 방법

- 여권 스캔
- 핸드폰 카메라로 여권 소지자 사진 촬영하여 제출
- 범죄 확인 질문 및 호주에서의 연락처 등 몇가지 질문에 응답
- 비자비용(A\$20) 지불 - 신청서 제출 완료 (보통은 바로 ETA 결과가 전달되며, 최대 12시간 지연될 수 있음) - 등록된 본인 이메일로 본인 ETA 컨펌 내용 확인

What is an Electronic Travel Authority?

An Electronic Travel Authority (ETA) provides authorisation to travel to and enter Australia and is electronically linked to the applicant's passport.

It is for short term stays for tourism or business visitor activities such as attending a conference, making business enquiries or for contractual negotiations. Business visitor activities do not include work.

An ETA is not a work visa. If the applicant would like to work in Australia they can use our Visa Finder to search for a visa that is suitable for them, visit [Visa Finder](#).

Travel requirements

From 21 February 2022 all visa holders who are fully vaccinated for international travel purposes can travel to Australia without a travel exemption. Unvaccinated visa holders will still need a valid travel exemption to enter Australia.

The applicant must be present with their passport/s and have a valid email address to apply using the Australian ETA App. All fields in the application are mandatory unless otherwise stated. To apply, the applicant will be required to:

1. Allow the app to scan their passport and read the passport chip.

A photo of the personal data page of the passport will be taken and the information contained on that page and in the passport chip will be used for the purpose of completing some of the application.

2. Take or have a photo taken of themselves.

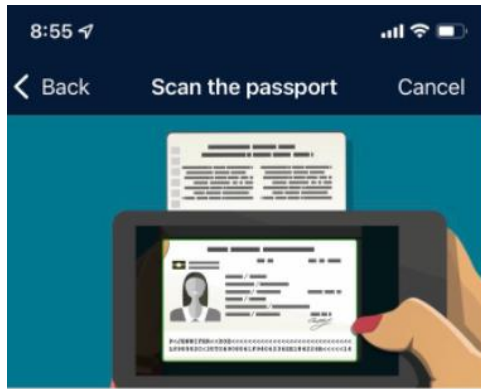
This confirms the person applying for the ETA is the same person shown in the passport.

3. Answer a few questions.

Not all of the information necessary to complete an ETA application can be obtained directly from the passport. The answers to these questions provide more information to assist in the processing of the application.

Use the valid passport the applicant will use to travel to Australia.

How to scan the passport.

Remove any cases or covers from the applicant's passport and the mobile device.

Open the applicant's passport to the personal data page and place the passport on a flat surface.

Ensure your fingers do not cover any of the personal information.

Avoid any glare, reflections or shadows.

The full page must be inside the frame, including the two lines of numbers and letters at the bottom of the page. The app will prompt you to adjust the device to make sure you capture the applicant's passport correctly. These prompts will appear at the

How to read passport chip

Place the mobile device on top of the passport's front cover.

Make sure that the mobile device is touching the passport cover with no gap between them.

Slide your device slowly around the passport until the app recognises the passport chip. The chip is located in different places in different passports.

Keep your device still when the app starts reading the passport chip.

How to take the applicant's photo

Take a portrait photo of the applicant in front of a plain background.

Ensure there is adequate lighting and no shadows. If possible, the applicant should wear a plain top.

Position the applicant's face in the circle as you would for a passport photo.

When the applicant's face is in the correct position, the app will take the picture for you.
